### **A Message from Quality Assurance**

As foster parents, you're the heart and soul of what we do. You're not just providing a home—you're champions for the educational, mental, medical, and emotional needs of the children in your care. These kids have faced challenges that no child should ever have to endure, and your role in their lives is absolutely life-changing.

Here's how you make such a big difference:

- **In School:** You're their biggest cheerleaders—advocating for special education services, individualized learning plans, or accommodations to help them succeed. Staying connected with teachers and school staff helps keep things on track and ensures the best outcomes for your kids.
- **Mental Health Matters:** You know these kids best, so you're often the first to notice when they're struggling with trauma or behavioral health issues. You can help ensure they receive the counseling, therapy, or other mental health services they may need to heal and grow stronger.
- **Health and Wellness:** From doctor's appointments to managing medications, you play a crucial role in navigating complex healthcare systems on behalf of the youth in your care to ensure they get the basic and specialized medical care they need.
- **Emotional Support:** Your home is their safe place, a space where they can begin to process their past, build resilience, and feel a sense of belonging. You can advocate for their emotional needs by connecting them with mentors, support groups, or other resources that assist them in developing self-esteem and confidence.

# The Foster Parent Law Corner: LCFS Foster Parent Law Implementation Plan of 2025

Lutheran Child and Family Services of Illinois (LCFS) improves the well-being of people across the state by protecting children, strengthening families and building futures for those who have experienced trauma. The LCFS Foster Parent Law Implementation Plan of 2025 serves as a comprehensive resource for foster parents, outlining their mutual rights and responsibilities as defined by the Illinois DCFS Foster Parent Law Rule 340, also known as the Foster Parent Code, to ensure clarity, collaboration, and informed caregiving.

This plan will be reviewed and discussed throughout the year during monitoring and home visits, foster parent forums and staff meetings with foster parents and LCFS staff. The implementation process includes reviewing LCFS' plan and having each foster parent sign the LCFS Foster Parent Law Implementation Plan

of 2025 Signature Page which will then be placed in his/her licensing record, acknowledging the receipt of the information and understanding of his/her rights and responsibilities as a foster parent in the State of Illinois.

#### **Foster Parent License Renewal**

Renewals for foster parent licenses are conducted every four years. To ensure a smooth renewal process, applications will be sent out six months prior to the expiration date. We encourage all foster parents to complete their required training each year to avoid any last-minute rush as the expiration date approaches.

Please be aware that if you are involved in an adoption or guardianship process, your renewal cannot be finalized until all training hours have been completed.

- For a traditional foster parent, this includes a requirement of 16 training hours, along with additional training in LGBTQ+ issues and educational advocacy. (4 training hours per year)
- For specialized homes, such as those providing educational advocacy, a total of 64 training hours is required, including the aforementioned topics. (16-17 training hours per year)

In addition to completing training, please ensure that the following items are up-to-date for your renewal:

- 1. A current physical examination
- 2. Recent pay stubs
- 3. Current insurance cards
- 4. Up-to-date pet vaccinations
- 5. Completion of a renewal application

Licensing staff will continue to monitor and assist you in completing your yearly training requirements as you approach your expiration date.

# Did You Know? The 2025 DCFS Scholarship Application is Now Open!

The 2025 DCFS scholarship application for current and former youth in care opened on January 1. Students can create an account now and log in to apply. Please encourage 2025 high school graduates and current college students to apply and submit their application early to allow time for the DCFS Office of Education and Transition Services to confirm completeness and request additional documentation from the student if necessary. #### **Guidelines for Good Interaction with the Children in Your Care**

#### **Emotional:**

- Showing positive feelings toward the child.
- Following and responding to the initiatives of the child.
- Establishing an intimate dialogue, both verbal and nonverbal, with the child.
- Praising and giving approval to the child.

#### Mediational (Comprehension):

- Sharing experiences and helping the child to focus on things and situations in their environment.
- Conveying meaning and enthusiasm for the child's experiences.
- Expanding and enriching the child's experience by connecting topics and making comparisons through imagination and logic.



#### Mediational (Regulation):

- Supporting the child with boundaries by planning step-by-step to help the child to develop self-control.
- Supporting the child with scaffolding (gradual support) to encourage initiative and competency.
- Using situations and set routines to guide behavior.
- Regulating and guiding the child's actions by positively setting consequences to develop responsibility and moral understanding.

This valuable and important information was taken from one of the manuals of our parent training from "Best Start for Families."

If you're interested in getting training through our "Best Start for Families" program, please reach out to your licensing representatives for more information. This training will count towards your annual license renewal hours.

#### **Refer Foster Parents and Receive Rewards**

All types of people make good foster parents as we all have our own special talents. As a foster parent you know better than anyone what it takes to answer this call. So we need your help.

If you refer someone new to become an LCFS foster family, you can receive:

**\$100** if the referred individual/family submits an application to LCFS and gets fingerprinted.

\$150 more if the referred individual/family then becomes licensed.

Be sure the prospective foster parent lists your name on their application under who referred them.
